TAKE CARE UTAH (TCU) WAS LAUNCHED IN 2010 AS A COMMUNITY-BASED HEALTH INSURANCE ASSISTANCE PROGRAM. IT HAS SINCE EXPANDED SIGNIFICANTLY AND SERVES PRIMARILY LOW-INCOME AND UNDESERVED UTAHNS OF DISPARATE BACKGROUNDS, INCLUDING INDIVIDUALS WHO ARE REFUGEES, HISPANIC, HOMELESS, LGBTQ, OR WHO STRUGGLE WITH SUBSTANCE ABUSE DISORDERS. THE ORGANIZATION MANAGES HEALTH ACCESS ASSISTERS DIRECTLY AND PROVIDES TRAINING, SUPPORT, AND AN ONLINE LOOKUP TOOL TO ADDITIONAL ASSISTERS MANAGED BY OTHER ORGANIZATIONS ACROSS THE STATE.
